


A report from the field: Survey statistics

- Total: 43 / 49 (88%)
- Human Subjects:
 - No: 17 (40%)
 - Yes: 26 (60%)
 - Prospective: 19
 - Retrospective: 13

* 6 projects have both prospective and retrospective subjects



- "The subjects may be particularly hesitant to respond this question (our population subject may include unauthorized immigrants, homeless, etc.), and it will also be problematic for the IRB process."
- "This question is intrusive and could dissuade many individuals from participating."
- *"Families will be distrustful and will not join."*

Some Observations about CDEs

- A clear need for a set of revised minimum CDEs for children
- Expected impact on patient recruitment
 - Sensitive information, especially for underserved populations, may result in a biased sample
 - Attrition: Time spent may become excessive, relative to test (e.g., a smell test: 2 minutes test vs. ~20 minutes minimal CDEs collection)
- Over time we will learn which items are consistently skipped and cause the most issues
